Due to non functioning of the website of CDSL, the Scrutinizer was not able to download the reports in time. The Company had clarified that due to delay caused to Scrutinizer on account of ongoing problem in CDSL website, the voting results were reported late to the Company. The Scrutinizer's Report dated 23.11.2022 was received by the Company on 24.11.2022. The Company however uploaded the voting results on 24.11.2022 itself upon receipt of said voting results. But the Company did not receive any reply from BSE/MSEI in this regard and finally the fine amount was paid under protest to them though there being no fault of the Company.
